

FBRN Foster to Adopt Agreement

French Bulldog Rescue Network (FBRN) has been given custody and care of French Bulldog puppies.

Whereas, FBRN desires to provide a supportive, healthy and safe environment for each dog in its custody and care; and

Whereas, veterinarians have performed initial medical examinations of each dog in FBRN's temporary custody, and have provided each dog with necessary age appropriate basic vaccinations; and

Whereas, FBRN is a qualified rescue group and has qualified individuals to provide care and necessary sustenance to the dogs in its temporary custody;

I, _____, make the following statements and voluntarily enter into this agreement to provide temporary care and custody and necessary sustenance as a foster to adopt caregiver to FBRN Rescued Dog named: _____ (herein "my foster dog").

I agree to provide an FBRN representative access to my home for a home inspection before my application to foster is approved.

I agree that the period covered by this agreement is the entire time during which I have custody of my foster dog.

I certify that I am over 21 years of age.

I agree to provide my foster dog with proper and routine veterinary care, including a yearly wellness exam, current required vaccinations, and urgent and emergency care as needed. I also understand that I must and agree that I will keep my foster dog on monthly heartworm preventative medication.

I understand that I am financially responsible for all proper and routine veterinary care described in the preceding paragraph, including vaccinations, as well as for all food and shelter, for my foster dog.

I understand that FBRN provides no guarantee as to the health of my foster dog, and that my foster dog may have significant medical needs, socialization problems, and not be housebroken.

I will arrange and pay for the sterilization (spay or neuter). I agree that I am fostering this dog for FBRN, and that I do not have any right of ownership over my foster dog until the puppy is sterilized and FBRN has formally approved the my adoption. I further agree that FBRN's rights in and to my foster dog are superior to mine.

I agree to provide a FBRN representative access to my home to check on my foster dog, at any time, with reasonable notice.

If FBRN is forced to undertake any action to enforce any provision of the agreement, I agree to indemnify FBRN for all court costs and attorneys' fees connected with such an

action.

If I am planning to move at any time during the period covered by this agreement, I agree to contact FBRN's representative, (contact information below), prior to my move, with new contact information. I understand that FBRN has the right to request return of my foster dog based on such a change of residence, and agree that I will surrender my foster dog to FBRN immediately upon request.

I understand that because the provisions of this agreement are subject to a court order, any violation of this agreement could result in legal liabilities for FBRN and myself. I agree to defend, indemnify and hold harmless FBRN, its director, officers and volunteers from any such legal liabilities that result from my violation of this agreement.

I understand that, as long as I provide foster care to my foster dog to FBRN's satisfaction, I will be given the first right of adoption of my foster dog, at such time as FBRN decides to offer my foster dog for adoption after sterilization.

If at any point I can no longer, or do not want to continue to, provide care, food, shelter or veterinary care for my foster dog, I agree to contact FBRN and arrange for transport of my foster dog back to FBRN.

I agree not to transfer possession or custody of my foster dog to any other person at any time.

I agree to contact FBRN with any and all questions or concerns about my foster dog or the fostering program, as well as with updated contact information. I also agree to provide FBRN with monthly reports on the health, behavior and general welfare of my foster dog.

I agree that if I refuse to comply with any provision of this agreement, FBRN has the right to terminate this agreement and also has the right to an immediate return of my foster dog and any other dogs for whom I am providing foster care for FBRN.

I agree that the opportunity given to me to help rehabilitate my foster dog, as well as the chance of a potential future adoption, is of significant benefit to me, and serves as proper legal consideration in exchange for my agreements stated in this contract.

I have read this Agreement in its entirety, and I agree that all statements and stated agreements contained in this document are made by me, and are truthful.
